DP World ILT20 Season 3 Raffles

Terms and Conditions

These Terms and Conditions govern your participation in the DP World International League Twenty20 ("ILT20") Season 3 Raffle process for both the Mega Raffle and the Daily Raffle (collectively the "Raffles"). Both Raffles for ILT20 Season 3 will run from 00:01 (UAE time) on 11 January 2025 to 23:59 (UAE time) on 09 February 2025 (the "Raffle Period"). The draw timings for both Raffles will be confirmed closer to the match dates.

By purchasing an ILT20 Season 3 match ticket and participating in the Raffles, you agree to be bound by and comply with the terms and conditions below. Any entries not complying with these terms and conditions will not be valid.

1. Raffle Structures

A. Mega Raffle

The Mega Raffle will be held on the day of the Final Match the ILT20 Season 3 i.e. 9th February 2025.

Mega Raffle Prizes:

- One (01) Audi Car Model A3 (2025)
- Ten (10) Tourist Package Deals (includes Hotel Stays for Couples in UAE for 2 nights and 3 days in a five-star on Bed & Breakfast and a Trio package comprising Desert Safari, Dubai City Tour and Dhow Cruise)

Note: The total number of winners under the Mega Raffle shall be eleven (i.e. one winner of the Car and ten winners of the Tourist Package).

B. Daily Raffle

The Daily Raffle will be held during each Match including the final match of the ILT20 Season 3.

Daily Raffle Prizes:

3 Gold Coins 6 grams each (3 Winners Daily/Per Match)

2. Eligibility

- 2.1. In order to be eligible to enter both the Mega Raffle and the Daily Raffle ("Eligible Entrant"), all participants must:
- a) have purchased a valid ILT20 Season 3 Match Ticket;
- b) attend the match by having their ticket scanned at the entrance gate for relevant match;
- c) In the event the winner of the Mega Raffle is a minor under the age of eighteen (18), a parent or legal guardian holding a valid UAE driving license may accept the Prize on behalf of the winner by providing proof of relation or legal guardianship to the satisfaction of ILT20.
- d) In the event the winner is above the age of eighteen (18) but does not hold a valid driving license, the winner may provide a release or no objection letter appointing a parent or spouse holding a valid UAE driving license to accept the Prize on his/her behalf. Proof of relation shall have to be submitted by the winner to the satisfaction of ILT20.
- e) In the event the Winner of the Car in the Mega Raffle is a non-UAE Resident, all Mega Raffle and Daily Raffle prizes are non-transferable, unable to be exchanged or amended and cannot be redeemed for cash. In the event of the Car Winner being a non-UAE Resident, they shall be required to nominate a Resident of the UAE (having a valid Emirates ID & UAE Driving license)

for the purposes of registration of the car in order to collect their prize and may thereafter choose to sell the same if they are unable to use the Car themselves.

- 2.2. Only paid ticket holders who have purchased match tickets through official channels are eligible to participate in the Raffles. Complimentary ticket holders, performers, and their families are excluded from participation in both Raffles and will not be considered for the draws.
- 2.3. All tickets scanned at the entrance for the ILT20 Season 3 matches being held at the Dubai International Stadium, Dubai, Sharjah Cricket Stadium, Sharjah and Zayed Cricket Stadium, Abu Dhabi will automatically be entered into the Raffles.
- 2.4. The identification of Eligible Entrants will be conducted through the scanned ticket number. Individuals may purchase as many tickets as they like and each scanned ticket will be a separate entry into the Raffle.
- 2.5. It is clarified that the following shall not be eligible to participate in the Raffles:
- a) employees, consultants, agencies and service providers (including their personnel) who are working with the ILT20;
- b) ILT20 Management, organisers and venues hosting the Season 3 matches;
- c) employees and Management of the Emirates Cricket Board (ECB);
- d) any person(s) directly or indirectly involved in the organisation of the ILT20 Season 3; and
- e) any person attending the match on a complimentary ticket.
- 2.6. In the event of any dispute arising out of or in connection with any Entrant's entry/eligibility to the Raffle, ILT20 reserves the right to retract any Prize from the Entrant.

3. Selection of Winners

Selection of winners will happen automatically, through randomized selection process.

3.1 Mega Raffle Selection:

- a) Shortlisting: During each relevant Match, fifty (50) ticket numbers will be selected randomly using the computerized random selection method for the final Mega Raffle draw. The selected tickets will be announced on the ILT20 website after each relevant match.
- b) Final Selection: These 50 selected tickets for each match will be added in the pool for the final lot, out of which 1 Car Winner and 10 Tourist Package Winners will be drawn through a final digital random selection process using the computerized random method.
- c) The final eleven (11) Mega Raffle Winners will be drawn and announced during the course of the final match of ILT20 Season 3 on Sunday, 9 February 2025 at the Dubai International Stadium, Dubai.

3.2 Daily Raffle Selection:

a) Shortlisting: From the fifty (50) ticket numbers selected randomly using the Computerized Random Methodas mentioned at point 3.1(a), the software will further select a total of three (3) ticket numbers as the 3 Daily Raffle Winners for the relevant match, which shall be announced inside the Stadium during the course of the relevant match.

4. Notification of Winners and Prize Collection

4.1 For each Raffle draw (Mega and Daily), the list of tickets selected for the relevant draw and the name of winners of the final draw will be uploaded on ILT20 website after every match

- <u>www.ilt20.ae</u> (the "Website"). In addition, name of winners of the final draw will be announced on social media and ILT20 reserves the right to announce the winners on other media platforms.
- 4.2 Photos and names of the winners will be published on ILT20's social media channels and the Website. ILT20 reserves the right to announce the winners on other media platforms as it may decide from time to time. Winners may also be requested by ILT20 to share pictures of themselves, social media content, or to share video or photo footage of themselves. Winners acknowledge and agree that no compensation will be provided for this.

4.3 Winners of the Mega Raffle:

- a) Mega Raffle Winners whose names have been announced will be contacted via call, WhatsApp and/or email and must report to the designated Raffle Info Desk located at the Cricket Carnival Area / Event Office at Dubai International Stadium along with their Identification Document (i.e. Emirates ID for UAE Residents and Passport for Non-UAE Residents) in order to claim their prize.
- b) The Mega Raffle Winners will be required to return the next day for completion of formalities and the collection of their prize.
- c) If a selected winner is disqualified, cannot be reached, or fails to claim their Prize, the winner will be deemed to forfeit their prize and it will be awarded to a substitute winner. If, having attempted to contact a winner and a substitute winner, ILT20 is unable to award a prize, ILT20 reserves the right to consider the prize unclaimed.
- d) The selection of winners made by ILT20 for each match are final and binding on all aspects relating to the Raffle

4.4 Winners of the Daily Raffles:

- a) Daily Raffle Winners whose names have been announced will be contacted via call, WhatsApp and/or email and must report to the designated Raffle Info Desk located at the Cricket Carnival Area at relevant stadium / Event Office along with their Identification Document (i.e. Emirates ID for UAE Residents and Passport for Non-UAE Residents) in order to claim their prize.
- b) If a selected winner is disqualified, cannot be reached, or fails to claim their Prize within the time period stipulated in clause 4.4(e) below, the winner will be deemed to forfeit their prize and it will be awarded to a substitute winner. If, having attempted to contact a winner and a substitute winner, ILT20 is unable to award a prize, ILT20 reserves the right to consider the prize unclaimed.
- c) The selection of winners made by ILT20 for each match are final and binding on all aspects relating to the Raffle.
- d) Winners will be briefed on the specific terms and conditions of their prize and a photo opportunity for digital use will be arranged for them.
- e) The Daily Winners if not present at the stadium when contacted after the announcement, will be required to collect the Daily Raffle Prize within 2 days of the Raffle announcement and notification. In case the Daily Prize is not collected within the stipulated time frame as above, it would be deemed as forfeited and the next person in sequence as per the relevant draw will be the new winner.
- 4.5 Prizes will only be handed over to the respective Winners after completion of all legal formalities, including but not limited to ILT20's verification of identification documents submitted by Winner(s). All prize winners shall remain responsible for the use of their respective prizes, including complying with all relevant laws and any applicable terms and conditions of use. For the avoidance of doubt, it is clarified that the ILT20 shall not be responsible in any way whatsoever for the delivery, any delay in delivery and/or the non-delivery of the prize(s).
- 4.6 All costs, fees, charges or expenses associated with the prize(s), which are not specified in the terms and conditions of a particular prize shall be the responsibility of the Winner(s), including any registration and insurance fees or relevant travel expenses (in case of Mega Raffle prizes).

5. Disqualification

- 5.1 ILT20 reserves the right to disqualify any participant/Eligible Entrant from the Raffle(s) who is found to have violated these Terms and Conditions or engages in any fraudulent activities or inappropriate behaviour, including ticket fraud, making multiple submissions using the same ticket number, or failing to comply with the Raffle entry process.
- 5.2 Disqualified participants may not be eligible for any prizes, and alternative winners may be selected. ILT20 shall have no liability for any loss or damage arising from such disqualification.

6. Personal Data

- 6.1 By participating in the Raffles, you consent to the collection and use of your personal information (including your name, ticket details, photographs and contact information) for the purpose of conducting the Raffles, awarding prizes and other promotional activities related to the ILT20 Season 3 tournament.
- 6.2 All personal data will be handled in accordance with applicable privacy laws and ILT20's Privacy Policy.

7. Liability and Responsibility

- 7.1 ILT20 and its affiliates shall not be responsible for any technical issues, malfunctions, or delays affecting the ticket scanning, entry submission, or Raffle process.
- 7.2 ILT20 assumes no liability in contract, tort, negligence, or otherwise for any loss, damage (including direct or consequential loss), injury, or inconvenience arising from participation in the Raffle or the collection or use of prizes.
- 7.3 All prizes are awarded "as is," and ILT20 makes no warranties or representations regarding the condition, value, or quality of the prizes.

8. Indemnity and Release

- 8.1 By participating in this Raffle, and to the extent permitted by the applicable laws of the UAE, each Eligible Entrant agrees to release, discharge, indemnify and hold harmless ILT20 and its parent, subsidiary, affiliate and related companies; its directors, officers, employees, consultants, advisors and advertising/promotion agencies and other suppliers from and against any and all claims, liability, costs, losses, damages or injuries of any kind arising out of or related to the their participation in the Raffles.
- 8.2 The Eligible Entrant hereby declares that they shall not make any demand, complain or claim against ILT20, its parent, subsidiary, affiliate, and related companies; its directors, officers, employees, advisors and advertising/promotion agencies in respect of any matter relating to or in connection with the Raffles.

9. General Terms

- 9.1 ILT20 reserves the right, at its sole discretion, to amend, suspend, or cancel the Raffle process for any reason, including technical issues or unforeseen circumstances beyond the control of ILT20, without any prior notice.
- 9.2 These Terms and Conditions may be updated by ILT20 from time to time. Participants should review the latest version on the official ILT20 Website.

- 9.3 By participating, you agree to abide by these Terms and Conditions and the decisions of ILT20 (including the results of the Raffles), which are final and binding in all matters related to the Raffles.
- 9.4 Failure by ILT20 to enforce any of its rights as afforded by these Terms and Conditions at any stage does not constitute a waiver of such rights.

10. Governing Law

- 10.1 These Terms and Conditions are governed by the laws of the United Arab Emirates (UAE).
- 10.2 In case of any disputes may arise out of or in connection with these Raffle Terms and Conditions, the Courts of Dubai, UAE shall have the exclusive jurisdiction to hear and determine any action or proceeding and to resolve the same.
